In addition, depending on their membership tier, members will be granted either Star Alliance Gold Member or Star Alliance Silver Member status.</p> <p>2. Details of the services provided at each membership tier and the Terms and Conditions for their provision shall be specified separately by ANA. These details may be subject to change.</p>

Article 4 (Issuance and Use of Membership Cards)

This club shall issue an "ANA Super Flyers Card" to members. This membership card shall be governed by the Mitsui Sumitomo VISA Card and Mitsui Sumitomo Mastercard Membership Agreement; the ANA VISA (Mastercard) Card Membership Special Terms and Conditions; the JCB Membership Agreement and ANA JCB Card Membership Special Terms and Conditions; the Diners Club Card/TRUST CLUB Card Membership Agreement and ANA Diners Card Membership Special Terms and Conditions; and the American Express Card Membership Agreement and ANA American Express Co-Branded Card Membership Agreement (hereinafter collectively referred to as the "ANA Card Membership Rules"). Membership cards may only be used by the named cardholder.

Article 5 (Issuance and Use of Membership Cards)

This club shall issue an "ANA Super Flyers Card" to members. This membership card shall be governed by the Mitsui Sumitomo Card Membership Agreement, the ANA VISA (Mastercard) Card Membership Special Terms and Conditions, the JCB Membership Agreement and ANA JCB Card Membership Special Terms and Conditions, the Diners Club Card/TRUST CLUB Card Membership Agreement and ANA Diners Card Membership Special Terms and Conditions, and the American Express Card Membership Agreement and ANA American Express Co-Brand Card Membership Special Terms and Conditions (hereinafter collectively referred to as the "ANA Card Membership Rules"). Membership cards may only be used by the named cardholder.

Article 5 (Validity Period of Membership)

The validity period of membership shall be the same as the validity period of the ANA Card, except in cases where Article 8 applies. Membership may be continued only where approved by ANA in accordance with Article 6, in which case a renewed membership card shall be issued.

Article 6 (Validity Period of Membership)

The validity period of membership shall be the same as the validity period of the ANA Card, except in cases falling under Article 9. Membership may be continued only where approved by ANA in accordance with Article 7, in which case a renewed membership card shall be issued.
