Changes to reservations and purchases for flights boarding from May 19, 2026 made after May 29, 2025 (start date of reservation/purchase)

1. Changes to key services	<a href="#">Seat Availability/Make Reservation function</a>	Will be redesigned from May 29, 2025. *The current design will be used for flights boarding up to May 18, 2026. Please select a fare option for seat availability inquiries.

Changes	Interchangeable airports	On the following routes where the fare booked allows changes, it will no longer be possible to change between the specified airports. - Fukuoka Airport ⇔ Kitakyushu Airport ⇔ Saga Airport ⇔ Fukuoka Airport - Hiroshima Airport ⇔ Iwakuni Airport

In addition to the one-way type fares, round-trip type fares are also available.

**Round-trip itinerary via the same airport or city**

Outbound: Tokyo to Osaka

Inbound: Osaka to Tokyo

**Point of arrival on outward journey different to point of departure on return journey**

Outbound: Tokyo to Fukuoka to (Traveling by car, railway, etc.) to Nagasaki

Inbound: Nagasaki to Tokyo


In addition to simple round-trip itineraries, itineraries with a point of arrival on the outbound journey that is different from the point of departure on the inbound journey can also be used.

\*Round-trip fares apply when the same fare is used to purchase the outbound and inbound flights at the same time.

## 4. Reservation changes and refunds

Changes (changes or refunds cannot be made only for specific reserved flights)



### 1. Before start of journey

The difference between the fare amounts before and after the change will be charged along with the reservation change charge\*1 specified for each fare.

If you have a reservation for a round-trip or transfer (using connecting airports) itinerary, even if changes are made only to one segment, the entire reservation record, including flights without changes, will be recalculated.


If all segments up to the arrival point cannot be reinstated, the recalculation cannot be performed and your reservation cannot be changed.

\*1 Some fares may not require a reservation change charge.

<Applicable fare amounts>On the change date, the fare amount valid on the start date of the trip will be applied to the entire itinerary.

(Seasonality, booking classes, etc.)

<Applicable reservation change charges>



### 2. After start of journey

The difference between the fare amounts before and after the change will be charged along with the reservation change charge\*1 specified for each fare.

If you have a reservation for a round-trip or transfer (using connecting airports) itinerary, even if changes are made only to one segment, the entire reservation record, including flights without changes, will be recalculated.

\*1 Some fares may not require a reservation change charge.

<Applicable fare amounts>On the purchase date, the fare amount valid on the start date of the trip will be applied to the segment that is being changed.



## 4. Reservation changes and refunds

Refunds (changes or refunds cannot be made only for specific reserved flights)




### 1. Before start of journey

A cancellation charge specified for each fare will be incurred in the event that a ticket is canceled.

Some segments are not refundable. After the refund of the entire reservation record is made, please make a new purchase for the required segments.

<[Applicable cancellation charges](#)> The number of days between the departure date of the outbound flight and the date the refund is made will be taken into account, and a cancellation charge will be incurred for the fare amount of the entire reservation record.



### 2. After start of journey

The refund amount is obtained by subtracting the charge for the fare amount of the entire reservation record (including used segments) from the difference between the fare amount of the entire reservation record (including used segments) and the fare applicable to the used segments.

The amount to be refunded may be calculated as zero.

<[Applicable cancellation charges](#)> If the itinerary is partially used, a cancellation charge will be incurred for the fare amount of the entire reservation record.

\*Refunds requested for cases in which the used segments do not form an itinerary will not be accepted.

## 5. Reservations with flights before and after May 19, 2026

It will not be possible to make reservations for flights before and after May 19, 2026 at the same time.

Reservations	Japan domestic fares applicable to flights boarding up to May 18, 2026 will be closed for new bookings, ticketing and boarding on May 18, 2026.	Fares that apply to flights boarding on or after May 19, 2026 can be booked and purchased from May 29, 2025 (from 9:00 a.m. Japan time).
Changes	Your ticket cannot be used for reservation changes or flights boarding on or after May 19, 2026, even if it is still valid.	Your ticket cannot be used for reservation changes or flights boarding on or before May 18, 2026.
Refunds	Refunds are accepted until May 18, 2026. If you wish to receive a refund on or after May 19, 2026, please contact the ANA Domestic Reservation and Customer Service Center.	Refer to <a href="#">the rules for changes and refunds for Japan domestic flights</a> for details.
