SWEEPSTAKES ENTRY PERIOD: ALL NIPPON AIRWAYS ("ANA") AND TOKYO CONVENTION & VISTORS BUREAU ("TCVB") "Luxury Tokyo" SWEEPSTAKES ("Sweepstakes") ENTRIES ACCEPTED BETWEEN 9:00 AM PACIFIC TIME ("PT") on October 1, 2025 and 11:59 PM (PT) on January 15, 2026 ("Sweepstakes Entry Period").

Prize:

One (1) winner will win round trip business class air transportation on ANA for two (2) from the U.S. ANA gateway airport nearest winner's residence to Tokyo ("ANA Ticket"), a two (2) night stay at The Prince Gallery Tokyo Kioicho, a Luxury Collection Hotel in Tokyo and a two (2) night stay at the Grand Prince Hotel Takanawa Hanakohro in Tokyo (the "Prince Hotel Stays" and collectively with ANA Ticket, the "Prize").

NOTE: Winner is responsible for the transportation arrangements and costs to/from the nearest ANA gateway airport and place of departure/return.

Co-Sponsors:

The stay at The Prince Gallery Tokyo Kioicho is approximately \$1,300 per night and the stay at the Grand Prince Hotel Takanawa Hanakohro is approximately \$1,400 per night.
